- have not been disqualified for a period exceeding 6 months in the last 3 years or been disqualified for a period exceeding 3 months during the past year
- Have not been involved in 3 accidents in the last 3 years as a 'driver'
- Have had no more than 2 theft claims in the last three years
- Have no more than 3 traffic endorsement penalty points

If you do not comply with these conditions **at any time** you would not be covered by our insurance and therefore personally liable for costs relating to any accident for which you are deemed responsible. If your circumstances change and you do not comply with the above conditions it is your responsibility to notify Co-cars immediately and to not use any cars owned by Co-cars until authorised to do so by a member of staff.
